#### **RELEASE FROM LIABILITY OF ALL CLAIM, INDEMNIFICATION & HOLD HARMLESS AGREEMENT**

In consideration of participating in gun club or hunting activities, and for other good and valuable consideration, I hereby agree to release and discharge from liability arising from negligence the Tusco Rifle Club, Inc. and its owners, directors, officers, members and employees, agents, volunteers, participants, and all other persons or entities acting for them (hereinafter collectively referred to as "Releases"), on behalf of myself and my children, parents, heirs, assigns, personal representative and estate, and also agree as follows:

- 1. I acknowledge that gun club or hunting activities involve known and unanticipated risks which could result in physical or emotional injury, paralysis or permanent disability, death and property damage. Risks include, but are not limited to, death or serious injury as a result of being shot or as a result of equipment malfunction; hearing loss; loss of vision; broken bones, bruises and other bodily injuries caused by falls; medical conditions resulting from physical activity, and damaged clothing or property. I understand such risks simply cannot be eliminated, despite the use of safety equipment, without jeopardizing the essential qualities of the activity.
- 2. I expressly accept and assume all of the risks inherent in this activity or that might have been caused by the negligence of the Releases. My participation in this activity is purely voluntary and I elect to participate despite the risks. In addition, if at any time I believe that event conditions are unsafe or that I am unable to participate due to physical or medical conditions, then I will immediately discontinue participation.
- 3. I, being of lawful age, in consideration of being permitted to be the participant and/or guest in the matches at Tusco Rifle Club Inc., or at any other place where such matches may be conducted, do for myself, my spouse, legal representatives, heirs and assigns, hereby voluntarily release, forever discharge and agree to indemnify and hold harmless Tusco Rifle Club Inc., its agencies, departments, its officers, trustees, agents, service and or club members, and employees in their official and personal capacities, their heirs, administrators and executors from any and all claims, demands or causes of action which are in any way connected with my participation at said matches or any activities in connection with these matches or my use of their equipment or facilities, arising from negligence. This release does not apply to claims arising from intentional conduct. Should Releases or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold harmless for all such fees and costs.
- 4. I represent that I have adequate insurance to cover any injury or damage I may suffer or cause while participating in this activity, or else I agree to bear the costs of such injury or damage myself. I further represent that I have no medical or physical condition which could interfere with my safety in this activity, or else I am willing to assume and bear the costs of all risks that may be created, directly or indirectly, by any such condition.
- 5. In the event that I file a lawsuit, I agree to do so solely in the state of Ohio, and I further agree that the substantive law of Ohio shall apply.
- 6. I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.

#### By signing this document, I agree that if I am hurt or injured in any way or my property is damaged during my participation in this activity, then I may be found by a court of law to have waived my right to maintain a lawsuit against the parties being released on the basis of any claim for negligence.

I have had sufficient time to read this entire document and, should I choose to do so, consult with legal counsel prior to signing. Also, I understand that this activity might not be made available to me or that the cost to engage in this activity would be significantly greater if I were to choose not to sign this release, and agree that the opportunity to participate at the stated cost in return for the execution of this release is a reasonable bargain. I have read and understood this document and I agree to be found by its terms.

Some are special rules for individual ranges to protect range equipment and to make sure each range is used properly. If you have any questions about these rules, please call an officer or trustee. Please shoot safe and enjoy your time spent at Tusco!

## NRA SAFETY RULES TO BE FOLLOWED AT ALL TIMES ON ALL RANGES

1. <u>ALWAYS</u> KEEP THE GUN POINTED IN A SAFE DIRECTION DOWN RANGE 2. <u>ALWAYS</u> KEEP YOUR FINGER OFF THE TRIGGER UNTIL READY TO SHOOT 3. <u>ALWAYS</u> KEEP THE GUN UNLOADED UNTIL READY TO USE

## **MEMBERSHIP IDS MUST BE PRESENTED WHEN REQUESTED**

## TUSCO RIFLE CLUB BASIC RANGE RULES

- Members and guests must sign in and sign out at each range. List your name, the time in and the name of any guest you bring. Be sure to add your time out when you leave. When you are attending a scheduled event or meeting, you do not need to sign in as scheduled events are open to the public. Members may bring a guest one time only after one visit, they must join the club to continue using the facilities. Guests are not allowed to hunt on club property.
- NO alcoholic beverages or use of illegal drugs will be tolerated on Tusco property. Persons doing so will be subject to expulsion from the club.
- Live firing on all ranges may commence at 8:00 am and must cease at sunset. The exception to this rule is the trap range which conducts its matches at 7:00 pm on Tuesday evenings under the lights (weather permitting) or any scheduled match approved by the trustees.
- The club is near residential property, please respect their rights.
- Members may use any of the club ranges except:
  - When a range is being mowed or worked on orange 'Range Closed' sign will be posted
  - When there is a scheduled event on a range check the calendar on website
  - During deer gun season ALL ranges are closed check the calendar on website
- Please keep vehicles on the roads and in designated parking areas.
- All-terrain vehicles are not permitted on club property without a permission slip signed by a trustee or officer.
- It is the responsibility of every club member to keep the club grounds clean. When you use a club range, leave it cleaner than you found it! Remove your targets and pick up your brass or wads and any trash. Trash cans are provided on all ranges as well as dumpsters for larger items and items that could possibly hurt someone.
- It is every club member's duty to report anyone destroying club property to an officer or trustee. Your name will be kept confidential (unless the issue must be referred to law enforcement).
- Tusco Rifle Club does not allow camera use (still or video) without the Match Director's permission and/or individual shooter's permission. You cannot film anyone else.
- NO TRACER, EXPLOSIVE, INCENDIARY AMMUNITION OR DETONATING TARGETS ANYTIME ANYWHERE!

#### Special safety rules ...

ALWAYS MAKE SURE GUNS ARE UN-LOADED WITH ACTIONS OPEN BEFORE LEAVING THE FIRING LINE
ALWAYS WEAR EAR AND EYE PROTECTION – THIS INCLUDES ANYONE ON THE RANGE

> ALWAYS BE SURE EVERYONE KNOWS YOU ARE GOING DOWN RANGE

- > ALWAYS SHOOT STRAIGHT DOWN RANGE NEVER CROSS FIRE
  - > ALWAYS KNOW YOUR TARGET AND WHAT IS BEYOND IT
  - > ALWAYS SHOOT FROM THE DESIGNATED FIRING LINE

## TUSCO RIFLE CLUB SPECIFIC RANGE RULES

#### ALL RANGES:

### ALL BRASS AND/OR WADS & TARGET DEBRIS MUST BE CLEANED UP & REMOVED!

#### **<u>RIM-FIRE RANGE</u>**

#### PERMISSIBLE FIREARMS:

• Only rim-fire rifles & pistols are permitted (.22, .22 Mag, 17HMR, .17H2, 5mm Rem.).

#### APPROVED TARGETS:

- Paper targets on wood, plastic or metal frame stands at least 12 inches above the ground level.
  - Manufactured metal reactionary type swinging and/or knock down targets.

#### 100 YARD RANGE

#### PERMISSIBLE FIREARMS:

• Pistols, rifles, slug guns & sub-machine guns allowed. 50 BMG firing prohibited.

#### APPROVED TARGETS:

- Paper targets on wood, plastic or metal frame stands at least 12 inches above the ground level.
  - Manufactured metal reactionary type swinging and/or knock down targets.

#### 50 YARD RANGE

#### PERMISSIBLE FIREARMS:

• Pistols, rifles, sub-machine guns & shot guns allowed.

#### APPROVED TARGETS:

- Paper targets on wood, plastic or metal frame stands at least 12 inches above the ground level.
  - Manufactured metal reactionary type swinging and/or knock down targets.
    - Clay targets on the impact berm.
- Cans, plastic bottles and jugs (NO glass) and wooden bowling pins may be used as targets if elevated at least 12 inches above ground level.

#### TRAP RANGE

#### PERMISSIBLE FIREARMS:

• Shotguns ONLY – maximum #4 shot – no slugs, buckshot, rifles or pistols.

#### APPROVED TARGETS:

- Clay birds only.
- Pattern board/paper allowed at designated area.

#### **INDOOR RANGE**

PERMISSIBLE FIREARMS:

• .22 rim-fire or air rifles and pistols ONLY.

**APPROVED TARGETS:** 

• Paper targets ONLY.

#### MAIN RANGE

#### PERMISSIBLE FIREARMS:

• Rim-fire & center-fire rifles and pistols only – NO 50 BMGs or full auto permitted.

#### APPROVED TARGETS:

- Paper targets only permitted on existing 200 & 300 yard target frames.
- Paper targets on wood, plastic or metal frame stands at least 12 inches above the ground level are permissible at 50 & 100 yards with acceptable backstop sufficient to prevent bullets from striking the steel protector plates for silhouette targets or damage to any other structures.

#### 600 YARD MATTHEWS RANGE

PERMISSIBLE FIREARMS:

- Center-fire rifles and rifle caliber pistols only NO full auto permitted.
  - 50 BMGs permitted with prior orientation.

#### APPROVED TARGETS:

- Paper targets on wood, plastic or metal frame stands at least 12 inches above the ground level or on target stands provided by the club. <u>MINIMUM FIRING DISTANCE 100 YARDS</u>
  - Manufactured metal reactionary type swinging and/or knock down targets.

TARGETS MUST BE PLACED STRAIGHT OUT FROM THE BENCH YOU ARE USING! MAKE SURE EVERYONE KNOWS THAT YOU ARE GOING DOWN RANGE & ALL GUNS ARE UNLOADED AND ON BENCH OR RACK.

#### UTILITY RANGE

#### PERMISSIBLE FIREARMS:

• All pistols, rifles, slug guns & sub-machine guns, full auto belt fed & 50 BMG

#### APPROVED TARGETS:

- Paper targets on wood, plastic or metal frame stands.
- Cans, plastic bottles and jugs (NO glass) and wooden bowling pins permitted.
  - Manufactured metal reactionary type swinging and/or knock down targets. ALL FIRING IS TO BE CONFINED TO THE TARGET CORRIDOR AREA.
